### Horizon 2020 - The final Work Programme 2018-2020 presented

This edition of the EaP PLUS newsletter focuses on the launch of the new Work Programme 2018-2020 of Horizon 2020 and the possibilities provided to applicants from the EaP region.

"The European Commission announced on October 27, 2017 how it will spend €30 billion of the EU research and innovation funding programme Horizon 2020 during 2018-2020, including €2.7 billion to kick-start a European Innovation Council. Horizon 2020, the EU's €77 billion research and innovation funding programme, supports scientific excellence in Europe and has contributed to high-profile scientific breakthroughs such as the discovery of exoplanets and gravitational waves" (EC Press Release, Brussels, 27 October 2017)

Highlight - new WP 2018-2020 of H2020 is published!



#### Horizon 2020 - The final Work Programme 2018-2020 presented

On October 27 the new WP 2018-2020 under Horizon 2020 was published. Over the next 3 years, the Commission will seek greater impact of its research funding by focusing on fewer, but critical topics such as migration, security, climate, clean energy and digital economy. Horizon 2020 will also be more geared towards boosting breakthrough, market-creating innovation. The 2018-2020 Work Programme build on the success of Horizon 2020 so far, and takes account of the extensive interim evaluation of the programme. It also responds to the European Commission's political priorities and paves the way for its successor programme. The new features include measures to support market-creating innovation, highly integrated activities called focus areas, emphasis on better dissemination of results and a focus on open access to data. The Work Programme also includes measures to increase simplification (e.g. lump sum funding), to widen participation from less performing countries and to address skills mismatches.

As you might know, all associated countries to Horizon 2020 are fully eligible to participate in any of the open calls in the new WP 2018-2020. From the EaP region, currently these are Armenia, Georgia, Moldova and Ukraine.

On the other hand, the new WP 2018-2020 includes two calls in 2018 plus two in 2019 ('SPIRE' calls) that encourage participation from all EaP countries, irrespective of their status in Horizon 2020.

SPIRE offers an unique opportunity for the researchers in the EaP countries to participate in consortia for preparing proposals with EU partners under H2020 "Industrial Leadership" (Nanotechnologies, Advanced Materials, Biotechnology and Advanced Manufacturing and Processing), since the respective calls recommend to EU applicants "to cooperate with the Eastern Partnership countries in particular".

EaP PLUS Coordinator George Bonas (CeRISS): "It is in the interest of the EU researchers to include scientists from EaP countries in order to fulfil all the recommendations of the SPIRE calls, increasing therefore the chances for acceptance of their proposal. In that context, a pro-active action from the EaP side will result in numerous applications and certainly an enhanced number of funded projects."

In parallel, EaP PLUS will implement a series of support actions to raise awareness about SPIRE and the new WP 2018-2020 in the EaP region:

- Information Days in each EaP country, with particular focus on SPIRE calls (more info)
- A Webinar on the SPIRE calls on 23rd November, that the researchers can freely attend (more info)
- Grants to travel in EU for meeting partners preparing SPIRE proposals (A call for these grants was launched on 5 November 2017) (more info)


Space International Information Day & Brokerage Event, Warsaw 13-14 December, 2017 (Dec 13—14, 2017 - Warsaw, Poland)

EaP PLUS cluster grant scheme for Georgia relaunched: call for applications (Submission Deadline: December 4, 2017)



# EaP PLUS Cluster Grant Scheme

The EaP PLUS project relaunches the grant scheme for Georgia for a period of 1,5 month! The call is open from October 17th 2017 to December 4th 2017. EaP PLUS offers 1 grant of up to 10.000€ to a Georgian cluster or cluster-like legal entity or organisation. The grant covers the expenses of the cooperative activites between Georgian and EU clusters. Read more about the eligibility criteria on our website.

Grants for networking in Brokerage Events or Preparatory Meetings for proposal applications in H2020 (focus: SPIRE) – 2nd call - Apply now!

(Submission Deadline: May 31, 2018)

The EaP PLUS Team happily announces the 2nd round of the Call for Grants for networking in Brokerage Events or Preparatory Meetings. This grant for networking financially supports the participation of local researchers from Eastern Partnership countries in Brokerage Events related to Horizon2020 and Preparatory Meetings for the development of H2020 project proposals. The 2nd round of the scheme will give special priority to applications concerning SPIRE calls which are explicitly encouraging participation from EaP countries.



SPIRE Call: Processing of material feedstock using non-conventional energy sources (IA) (Submission Deadline: February 22, 2018 )



Proposals are expected to develop technologies applying non-conventional energy sources to processes of high industrial interest. Activities should start at Technology Readiness Level (TRL) 4 and achieve TRL 6 at the end of the project. The Commission considers that proposals requesting a contribution from the EU between EUR 6 and 10 million would allow this specific challenge to be addressed appropriately. Nonetheless, this does not preclude

submission and selection of proposals requesting other amounts. Read more on the EaP PLUS website!

SPIRE Call: Energy and resource flexibility in highly energy intensive industries (IA 50%) (Submission Deadline: February 22, 2018)



The challenge is to establish synergistic integration at a regional level among different production sectors leading to optimisation of production system as a whole and logistics, especially in terms of the supply of energy and raw materials. This should reduce emissions and environmental impact, while maintaining competitiveness and job security. Proposals should include multiple demonstrators, including retrofitting of industrial installations, in a highly energy and resource intensive industry-relevant environment. Activities should start at Technology Readiness Level (TRL) 5 and achieve TRL 7 at the end of the project.

The Commission considers that proposals requesting a contribution from the EU between EUR 8 and 12 million would allow this specific challenge to be addressed appropriately. Nonetheless, this does not preclude submission and selection of proposals requesting other amounts. **Read more on the EaP PLUS website!**
