The main areas of activities:	<ul style="list-style-type: none"> • Developing conditions for implementation of joint innovative projects, promotion and commercialization of their results on the markets of China, Belarus and third countries, in particular, providing movable and immovable property, including premises of variable functionality; • Organizing joint undertakings and promotion of science-intensive and hi-tech products and projects; • Setting up scientific groups, joint laboratories, research centers and undertakings; • Search for investments for implementation of joint S&T projects; • Providing consulting services in legal and economic areas on conditions for becoming a resident of the S&T Park; • Monitoring joint innovative projects and implementation of contractual obligations; • Organizing and carrying out S&T events (exhibitions, seminars, conferences, cooperation exchanges, etc.); • Assistance in organizing trainings and staff exchanges within the specific innovative projects; • Providing other services, connected to research, technological and innovation activities of the Park; • Developing and considering innovation projects; • Partner search; • Assisting in signing contracts and agreements on implementation of innovation projects; • Assisting in patenting of R&D results in Republic of Belarus, People's Republic of China and the third countries.
